## 7. INFORMATION AND DISCUSSION

## 7.1 F.A.S.T. Coordinator Update

<u>EXPLANATION</u>: The Family And Students Together (F.A.S.T.) Coordinator is a new position for the Black Oak Mine Unified School District. The F.A.S.T. Coordinator serves as a liason between our schools and families on issues such as attendance, possitive behaviors and interventions, and student acheivement. The F.A.S.T. Coordinator will provide an overview of activites to date.

<u>EXPLANATION:</u> Dr. Wendy Westsmith will give a report on the results of the Local Indicators used to measure the progress of meeting the LCAP priorities and goals.

<u>BACKGROUND:</u> The State Board of Education approved standards for the local indicators that support an LEA in measuring and reporting progress within the appropriate priority area. The approved standards require an LEA to

annually measure its progress, report the results at a regularly scheduled public meeting of the local governing board, and report results to the public through the Dashboard.

#### 7.3 School Closure Discussion

<u>EXPLANATION:</u> Due to the Public Safety Power Shutoffs (PSPS), the Board has cause to discuss both short and lont term issues and potenial solutions.

## 7.4 Transportation - Field Trip Discussion

<u>EXPLANATION</u>: District staff will make a presentation to the Board on new fleet purchases for transportation, field trip data, and recommend the Board allocate \$25 per enrolled student at First Interim for the purpose of supporting field trip transportation in the District. The estimated \$25,000 of budgeted expenditures would allow each site administrator to allocate funds based on the field trip/experiential priorities of each site.

<u>BACKGROUND:</u> Field trips provide enrichment and experiences beyond the classroom for students in the Black Oak Mine Unified School District. In fact, the District's Local Control Accountability Plan recognizes the need to provide all students, especially those with special needs and from lower socio-economic backgrounds access to deeper, richer learning experiences in settings beyond the classroom. Moreover, our staff work exceptionally hard to organize and provide these opportunities for students in the form of various fundraising activities.

## 8.2 ACTION: Federal Addendum

<u>RECOMMENDATION:</u> It is recommended that the Board of Trustees consider approving the Federal Addendum as presented.

<u>BACKGROUND:</u> The LCAP Federal Addendum is meant to suppliment the LCAP to ensure that eligible LEA's have the opportunity to meet the Local Education Agency (LEA) Plan provisions of the Every Students Succeeds Act (ESSA).

The implementation of ESSA in California presents an opportunity to LEA's to innovate with their federally-funded programs and align them with the priority goals they are realizing under the state's Local Control Funding Formula (LCFF).

California's ESSA State Plan significantly shifts the state's approach to the utilization of federal resources in support of the underserved student groups. This LCAP Federal Addendum provides LEA's with the opportunity to document their approach to maximizing the impact of federal investments in support of underserved students.
